28	Whereas, the Town of Rangeley has scheduled on March 16, 1992 a vote on reestablishing the Rangeley Water District; and
30	Whereas, in the judgment of the Legislature, these facts
32	create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately

38	Further amend the bill by striking out all of section 1 and inserting in its place the following:
40	'Sec. 1. Territorial limits; corporate name; purposes. Subject to section 17, the inhabitants and territory within the Town of
42	Rangeley, beginning on the easterly shore of Rangeley Lake at the Rangeley and Rangeley Plantation town line, thence easterly to

Notwithstanding the Maine Revised Statutes, Title 30-A, section 5684, additional costs, if any, imposed on any municipality by the provisions of this Act providing for a local referendum are not funded by the State. 26 28 Emergency clause. In view of the emergency cited in the preamble, this Act takes effect when approved.' ! 30 32 STATEMENT OF FACT 34

This amendment replaces Committee Amendment "A" and removes Sandy River Plantation and Rangeley Plantation from the Rangeley Water District. The amendment retains the new section added by the committee amendment, making it clear that any minimal costs that the Town of Rangeley may incur as a result of holding the referendum in accordance with the provisions of the bill must be absorbed by that municipality.
