HOUSE AMENDMENT "K" to COMMITTEE AMENDMENT "A" to H.P. 14 1547, L.D. 2185, Bill, "An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State 16 Government for the Fiscal Years ending June 30, 1992 and June 30, 1993 and to Change Certain Provisions of the Laws"

Amend the amendment by inserting at the end before the 20 fiscal note the following:

'PART XX

Sec. XX-1. 3 MRSA §2, 2nd ¶, as amended by PL 1985, c. 166, is further amended to read:

The first regular session of the Legislature, after its convening, shall adjourn no later than the 3rd Wednesday in June 28 May and the 2nd regular session of the Legislature shall adjourn no later than the 3rd Wednesday in April. The Legislature, in 30 case of emergency, may by a vote of 2/3 of the members of each House present and voting, may extend the date for adjournment for 32 the first or 2nd regular session by no more than 5 legislative days, and in case of further emergency, may by a vote of 2/3 of 34 the members of each House present and voting, <u>may</u> further extend 36 the date for adjournment by 5 additional legislative days. The times for adjournment for the first and 2nd regular sessions may also be extended for one additional legislative day for the 38 purpose of considering possible objections of the Governor to any bill or resolution presented to him the Governor by the 40 Legislature under the Constitution, Article IV, Part Third, 42 Section 2.'

Reducing the length of the first regular session of the Legislature will allow the Legislature to operate within the level of appropriations proposed in this bill, resulting in no net effect on General Fund appropriations or revenues and maintains a balanced budget for fiscal year 1991-92 and fiscal year 1992-93.

STATEMENT OF FACT

14 This amendment amends the statutory deadline for adjourning the first regular session of the Legislature to reflect the 16 reduction in funding for fiscal year 1992-93.
