## FISCAL NOTE

The fiscal impact of this amendment on the General Fund can not be determined at this time.

## STATEMENT OF FACT

This amendment precludes closure or privatization of state 10 correctional, mental health or mental retardation facilities unless the state agency involved has a plan that ensures 12 demonstrated cost savings to the State and continued delivery of services at current levels. The amendment specifically excludes 14 the Maine Youth Center, as its privatization is authorized in Part QQ.
