SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to H.P. 1692, L.D. 2372, Bill, "An Act to Allow Municipalities to Appeal the New State Valuation"

Amend the amendment by striking out everything after the title and before the last paragraph before the fiscal note and inserting in its place the following:

'Amend the bill by striking out all of section 1 (page 1, lines 20 to 30 in L.D.)

Further amend the bill in section 2 in the 3rd line (page 1, line 34 in L.D.) by striking out the following: "Towns of Waterboro," and inserting in its place the following: 'towns of'

Further amend the bill in section 3 in the 4th line (page 1, line 46 in L.D.) by striking out the following: "2" and inserting in its place the following: '1'

Further amend the bill in section 3 in the 5th and 6th lines (page 1, lines 47 and 48 in L.D.) by striking out the following: "any of the municipalities listed in section 2 of this Act" and inserting in its place the following: 'the towns of Whitefield, Mechanic Falls and Franklin'

Further amend the bill in section 3 by striking out all of the last paragraph (page 2, lines 2 to 5 in L.D.) and inserting in its place the following:

'The State Tax Assessor shall calculate the amount of funds due any municipality from any source pursuant to this section and report that amount, together with implementing legislation for reimbursing the municipality, to the joint standing committee of
