SENATE AMENDMENT " $\neq$ " to COMMITTEE AMENDMENT "A" to S.P. 929, L.D. 2384

Part B of the bill provides for the transfer of the Bureau of Rehabilitation from the Department of Human Services to the Department of Education. The Department of Education can absorb the costs associated with preparing legislation to implement necessary statutory and budgetary changes. It can not be determined if this transfer will result in any cost savings.

Part C of the bill abolishes the State Planning Office in fiscal year 1993-94 and establishes a Director of State Planning in the Office of the Governor. It can not be determined if there will be future General Fund savings until the Legislature determines the reassignment of current program components to other state agencies.

This amendment strikes out the provisions in the committee amendment that move the child development services system and the Division of Alcohol and Drug Education Program from the Department of Education to the Department of Children Families.

The amendment also strikes out provisions in the committee amendment that establish the Bureau for the Blind and Visually Impaired in the Department of Education. The amendment moves the entire Bureau of Rehabilitation, except the Division Disability Determination Services, from the Department of Human services to the Department of Education. It also directs the Commissioner of Education to submit statutory and budgetary changes necessary for the transition to the 116th Legislature.
