'FISCAL NOTE

The estimated cost of sending this bond issue out to referendum is \$621,400 in fiscal year 1991-92. The Department of the Secretary of State will require a General Fund appropriation of \$121,400 in fiscal year 1991-92 for its own expenses for this bond referendum. A General Fund appropriation will also be required for the costs to municipalities of holding this special election, currently estimated at \$500,000.

HOUSE AMENDMENT "C" to H.P. 1707, L.D. 2388

The total cost of the bond issue is estimated to be \$65,939,000 with principal payments of \$50,000,000 and interest payments of \$15,939,000.

Debt service payments will come due in fiscal year 1992-93. A General Fund appropriation of \$1,593,900 will be required in fiscal year 1992-93 for the interest payments payable in that fiscal year. This figure assumes the first principal payment can be structured to be payable no sooner than fiscal year 1993-94 and that 2 interest payments will be payable in fiscal year 1992-93.'
