Amend the amendment by striking out all of section 7 and
inserting in its place the following:

Sec. 7. Appropriation. The following funds are appropriated
from the General Fund to carry out the purposes of this Act.

General Fund Debt Service Account authorized
under the Maine Revised Statutes, Title 5,
section 151-A, which will provide sufficient
funds to cover the projected debt service
requirement.

APPROPRIATIONS/ALLOCATIONS

Highway Fund	\$446,600

This bill includes a General Fund appropriation of \$796,950 for Debt Service costs in fiscal year 1992-93. There is also a corresponding deappropriation to the same account to reflect anticipated interest earnings. This amendment also includes a Highway Fund allocation of \$446,600 for new Debt Service costs in fiscal year 1992-93. The appropriations and allocations are contingent on the passage of the bond issue to be voted on at a primary election in June 1992.'

STATEMENT OF FACT

This amendment strikes an appropriation to the Department of Economic and Community Development for project staff related to infrastructure project improvements. This task will be absorbed within the department's existing budget.

This amendment also amends the General Fund appropriation to the Debt Service Account to reflect anticipated interest earnings.
