This bill includes General Fund appropriations totaling  
\$121,400 in fiscal year 1991-92 and \$2,774,853 in fiscal year  
1992-93 and a Highway Fund allocation of \$1,170,400 in fiscal  
year 1992-93. The appropriations and allocations in Part A of  
the bill are contingent on the passage of the bond issues to be  
voted on at a special election on April 14, 1992. The General  
Fund appropriations in Part B to the Secretary of State, \$121,400  
in fiscal year 1991-92 and \$500,000 in fiscal year 1992-93 are  
not contingent on the passage of the bond issues. The General  
Fund appropriations for the cost of the special election will be  
required whether or not the bond issues are approved by the  
voters.'
