HOUSE AMENDMENT "M" to HOUSE AMENDMENT "C" to H.P. 1783, L.D. 2464

2 Further amend the bill in Part A by striking out all of sections 4, 6 and 7.' '

Further amend the amendment in the first paragraph after the title in the first line (page 1, line 17 in amendment) by б striking out the following: "Amend" and inserting in its place the following: 'Further amend' 8

10 Further amend the amendment on page 7 by striking out all of the first 4 paragraphs (lines 4 to 34 in amendment) and inserting 12 in their place the following:

'Further amend the bill in Part A by striking out all of 14 sections 9 and 10 and inserting in their place the following:

'Sec. A-9. Application. This Part only applies to matters in which an injury occurs on or after January 1, 1993 and the 18 substantive and procedural provisions of the Maine Revised Statutes, former Title 39 apply to injuries occurring prior to 20 that date, except that the Workers' Compensation Board and its hearing officers shall fulfill the functions of the Workers' 22 Compensation Commission and its commissioners.

Further amend the bill in Part A by renumbering the sections to read consecutively.' ' 26

## FISCAL NOTE

This amendment may reduce the amount of savings resulting from the bill's changes to workers' compensation benefits. The effect on the estimated savings to the State and local units of 32 government as employers can not be estimated at this time.

## STATEMENT OF FACT
