A General Fund appropriation of approximately \$10,000 for advertising, travel reimbursement for candidates and public hearing expenses will be required by the State Board of Education for any year in which a new Commissioner of Education would be hired under the new selection process. This appropriation may be required in fiscal year 1994-95.'

The bill limited the functions of the State Board of Education to advising the Commissioner of Education and acting as the state agency responsible for administering federal vocational education funds.

The amendment strikes out the bill and replaces it with a provision requiring that the State Board of Education appoint the Commissioner of Education. Under current law, the Commissioner is appointed by the Governor. The amendment also adds a new bill title and a fiscal note.
