SENATE AMENDMENT " $\mathcal{H}$ " to COMMITTEE AMENDMENT "A" to H.P. 159, L.D. 211, Bill, "An Act Related to Lottery Machines"

16 Amend the amendment by inserting after the title the following:

'Amend the bill by inserting before the enacting clause the 20 following:

'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted
as emergencies; and

26 Whereas, the selection for placement and removal of lottery machines is an ongoing process that currently lacks specific 28 formal and consistent guidelines; and

30 Whereas, the development and implementation of a formal and consistent selection plan for lottery machines must be 32 immediately addressed to ensure fairness to all applicants; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,' '

40 Further amend the amendment in the first paragraph in the first line (page 1, line 16 in amendment) by striking out the 42 following: "Amend" and inserting in its place the following: 'Further amend'

SENATE AMENDMENT to COMMITTEE AMENDMENT "A" to H.P. 159, L.D. 211

Further amend the amendment in section 1 in subsection 4 in the 4th line from the end (page 1, line 27 in amendment) by striking out the following: "review" and inserting in its place the following: 'approve'

Further amend the amendment by striking out the fiscal note and inserting in its place the following:

'Emergency clause. In view of the emergency cited in the preamble, this Act takes effect when approved.

## **FISCAL NOTE**

The prohibition against removing any lottery machines until a written plan has been adopted may reduce General Fund revenues. The amounts will depend on when the plan is adopted and the specifics of the plan.

The Bureau of Alcoholic Beverages and Lottery Operations within the Department of Administrative and Financial Services will incur some minor additional costs to develop a written plan related to the placement of lottery machines. These costs can be 22 .absorbed within the bureau's existing budgeted resources.'

## STATEMENT OF FACT

This amendment adds an emergency preamble and an emergency clause.

Standing The amendment also clarifies that the Joint Committee on Legal Affairs must approve the commission's plan before the plan is implemented.

The amendment also replaces the fiscal note.
