Sec. III-1. 36 MRSA §1752, sub-§17-A, ¶F, as amended by PL 1989, c. 533, §§2 and 14, is further amended to read:

F. Custom computer programming, including, but not limited to, modification of a standard program; and

Sec. III-2. 36 MRSA §1752, sub-§17-A, ¶G, as enacted by PL 1989, c. 533, §§3 and 14, is amended to read:

G. Rental of video tapes and video equipment; and

Sec. III-3. 36 MRSA §1752, sub-§17-A, ¶H is enacted to read:

H. Sales of extended warranties or other forms of dealer protection plans.

Sec. III-4. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Part.
