Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Sec. 1. 38 MRSA §1310-N, sub-§6, as amended by PL 1991, c. 644, §1, is further amended to read:

6. Terms and compliance schedules. Licenses are issued under the terms and conditions as the department may prescribe, 20 and for a term not to exceed 5 years. The department may 22 establish reasonable time schedules for compliance with this article and rules adopted by the board. Notwithstanding any rules adopted pursuant to this section, licensed or unlicensed 24 municipal solid waste landfills operating on December 31, 1991 may continue to operate until December 31, 1992 1993, unless the 26 commissioner finds that continued operation of a landfill poses 28 an immediate hazard to the public health or the environment, including without limitation, a threat to a public or private The commissioner may allow a licensed or 30 water supply. unlicensed municipal solid waste landfill that was operating on December 31, 1991 to continue operating until June 30, 1994, if 32 the commissioner determines that:

A. The municipality in which the landfill is located has formed a committee to study options for municipal solid waste management;

40 <u>B. The committee to study options has developed a written</u> 40 <u>plan for implementing those options;</u>

- 42 <u>C. The municipality has expended money to maintain the</u> landfill in the best operational condition possible; and
- D. The municipality is moving toward compliance with the46solid waste laws and rules adopted under this subchapter.

Page 1-LR1122(1) L.D. 413 **Emergency clause.** In view of the emergency cited in the preamble, this Act takes effect when approved.

STATEMENT OF FACT

This bill extends the municipal solid waste landfill closure 8 deadline by one year, to December 31, 1993 and allows the Commissioner of Environmental Protection to grant a conditional 10 6-month extension to a licensed or unlicensed landfill that is otherwise required by law to cease operations on December 31, 12 1992. A municipality is eligible for an extension if the commissioner determines that the municipality in which the 14 landfill is located is making reasonable and productive efforts toward finding an alternative method of solid waste management.
