	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 12 MRSA §7627-B is enacted to read:
4	§7627-B. Violation of litter laws.
6	<u>A person is guilty of a violation of Title 17, section 2264</u>
8	if that person owns a shack or temporary structure and allows that structure to remain on private property without permission
10	of the landowner for more than 15 days.
12	Sec. 2. 17 MRSA 2263, sub-§1-D is enacted to read:
14	1-D. Abandoned. "Abandoned" means left unattended for 15 days or more.
16	Sec. 3. 17 MRSA §2263, sub-§2, as amended by PL 1973, c. 194,
18	is further amended to read:
20	<b>2. Litter.</b> "Litter" means all waste materials including, but not limited to, any bottles, glass, crockery, cans, scrap
22	metal, junk, paper, garbage, rubbish, offal, feathers, except feathers from live birds while being transported, <u>abandoned</u>
24	temporary structures or shacks used for ice fishing, old automobiles or parts thereof of automobiles, or similar refuse,
26	or disposable packages or containers thrown or deposited as prohibited in this chapter, but not including the wastes of the
28	primary processes of mining, logging, sawmilling, farming or manufacturing.

32	STATEMENT OF FACT
34	This bill defines an ice fishing shack left unattended for 15 days or more as litter. The penalties and violations that
36	apply to litter apply to these abandoned structures.
