The bill as amended by the committee amendment required a one-stop permitting process involving all permits required of retail stores. This amendment excludes permits issued by the Department of Environmental Protection, the Department of Marine Resources and the Maine Land Use Regulation Commission. It adjusts agency funding participation accordingly.
