HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 399,
L.D. 512, Bill, "An Act to Centralize Licensing for Retail
Businesses"

Amend the amendment in section 1 in subsection 5 in the 3rd
line (page 1, line 31 in amendment) by inserting after the
following: "all" the following: 'permits required by' and in
the last line (page 1, line 32 in amendment) by striking out the
following: "consumer." and inserting in its place the
following: 'consumer, except permits issued by the Department of
Environmental Protection, the Department of Marine Resources and
the Maine Land Use Regulation Commission. Agencies and permits
referred to in subsections 5 to 8 do not include these excepted
agencies or permits issued by them.'

Further amend the amendment in section 1 in subsection 6 in
paragraph D in the 2nd paragraph in the 3rd line (page 3, line 10
in amendment) by striking out the following: "determine" and
inserting in its place the following: 'recommend'

Further amend the amendment in section 1 in subsection 6 in
the last paragraph by striking out the following: "program." and
inserting in its place the following: 'program, except that the
programs may not be extended to include additional issuing
agencies.'

Further amend the amendment in section 1 in subsection 7 in
the 2nd line (page 3, line 19 in amendment) by striking out the
following: "subsections 3, 4 and" and inserting in its place the
following: 'subsection'

program'

10 the 2nd line from the end (page 3, line 45 in amendment) by
inserting after the following: "businesses" the following: ',
12 to other issuing agencies'

14 **STATEMENT OF FACT**

16
The bill as amended by the committee amendment required a
18 one-stop permitting process involving all permits required of
retail stores. This amendment excludes permits issued by the
20 Department of Environmental Protection, the Department of Marine
Resources and the Maine Land Use Regulation Commission. It
22 adjusts agency funding participation accordingly.
