The Department of Public Safety will require General Fund appropriations and Highway Fund allocations totaling \$17,128 annually beginning in fiscal year 1993-94 for a part-time Clerk Typist II position and general operating expenses to collect and disseminate information as part of the Missing Children Information Clearinghouse.

These funds are appropriated and allocated on a 13% General Fund and 87% Highway Fund basis. The annual General Fund appropriations total \$2,227 and Highway Fund allocations total

2 \$14,901. The Governor's proposed current services budget
includes changes that affect the distribution of State Police
4 funding. This estimate of the fiscal impact may need to be
adjusted based on final legislative actions on the current
services budget.'
