Further amend the bill in section 1 in that part designated 26 "**§815.**" by striking out all of subsection 4 (page 1, lines 23 to 26 in L.D.)

Further amend the bill in section 2 in the 2nd line (page 1, 30 line 29 in L.D.) by striking out the following: "1992" and inserting in its place the following: '1993' '

Further amend the amendment in the first paragraph after the 34 title in the first line (page 1, line 16 in amendment) by striking out the following: "Amend" and inserting in its place 36 the following: 'Further amend'

38 Further amend the amendment in section 2 in the 6th line (page 1, line 27 in amendment) by striking out the following: 40 "\$600,000" and inserting in its place the following: '\$300,000'
