2	STATEMENT OF FACT

	The original bill unintentionally included employees of the
6	Maine Maritime Academy covered by a collective bargaining
	agreement in the group of employees to be exempted from salary
8	adjustments mandated by Public Law 1991, chapter 780. The
	exemption would have resulted in unbudgeted costs to the Maine
10	Maritime Academy of \$16,000.
12	The amendment excludes represented employees of the Maine
	Maritime Academy from the list of employees who are exempted from
14	the provisions of Public Law 1991, chapter 780. The amendment
	also adds a fiscal note.
