HOUSE AMENDMENT "" to S.P. 251, L.D. 770

D. To any criminal justice agency if necessary to carry out the administration of criminal justice, the administration of juvenile criminal justice or for criminal justice agency employment.

Notwithstanding any other provision of law, the department may release the names, dates of birth and social security numbers of 8 juveniles receiving services from the department and, if 10 applicable, the Medicaid eligibility numbers and the dates on which those juveniles received Medicaid services to the Bureau of Medical Services and the Bureau of Income Maintenance within the 12 Department of Human Services for the sole purpose of determining eligibility and billing for Medicaid services provided by or 14 through the department. Department of Human Services personnel 16 must treat this information as confidential in accordance with federal and state law. This paragraph does not authorize the 18 department to release client treatment plans, psychological profiles or criminal records to the Department of Human Services.

18 This bill will facilitate the reimbursement of federal Medicaid funds related to case management services in the 20 Department of Corrections, which will be credited to General Fund undedicated revenue. The Bureau of the Budget has estimated the 22 increase of General Fund revenue in fiscal year 1992-93 to be \$750,000.

This bill appropriates \$750,000 from the General Fund in 26 fiscal year 1992-93 to the Maine Youth Center for payroll obligations for the remainder of fiscal year 1992-93.'

## STATEMENT OF FACT

This amendment strikes the provision proposed by the bill and replaces it with a revised section that allows for release of certain information from the Department of Corrections to the Department of Human Services.
