Resolve, to Create the Commission on Education Rules.

Presented by Representative COLES of Harpswell. Cosponsored by Representatives: MITCHELL of Vassalboro, NORTON of Winthrop, Senators: AMERO of Cumberland, O'DEA of Penobscot. **Emergency preamble. Whereas,** Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this resolve establishes a commission to study the education rules affecting school administrative units; and

8 Whereas, the study must be initiated before the 90-day period expires in order that the study can be completed and a 10 report submitted to the next legislative session; and

12 Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of 14 Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and 16 safety; now, therefore, be it

18 Sec. 1. Commission established. Resolved: That the Commission on Education Rules, referred to in this resolve as "the 20 commission," is established; and be it further

22 Sec. 2. Commission membership. Resolved: That the commission consist of 7 members, 2 Senators appointed by the President of the Senate and 5 members of the House of Representatives appointed by the Speaker of the House of Representatives; and be it further

Sec. 3. Appointments: meetings. **Resolved:** 28 That all appointments must be made no later than 30 days following the end of the First Regular Session of the 116th Legislature. 30 The Executive Director of the Legislative Council must be notified by the appointing authorities once the selections have been made. 32 the Chair of the Legislative Council shall convene the first meeting no later than 45 days after the end of the First Regular 34 Session of the 116th Legislature; and be it further

Sec. 4. Duties. Resolved: That the commission shall conduct a comprehensive study of the Department of Education rules affecting school administrative units. In conducting the study, the commission shall:

1. Examine the authority and reasons for each rule;

2. Identify rules that require school administrative units to engage in redundant activity;

3. Determine the rules that are still needed, sensible and 48 reasonable; and

4. Make recommendations on how to rewrite the rules to eliminate rules that are redundant or no longer needed and to

Page 1-LR1904(1) L.D. 849 streamline the rules to minimize the burden they place on school administrative units.

The commission shall encourage participation in its deliberations by school administrative units, local school boards
and professional associations involved with schools; and be it further

Sec. 5. Staff assistance. Resolved: That the Executive Director 10 of the Legislative Council shall provide any necessary staff assistance; and be it further

Sec. 6. Reimbursement. Resolved: That the commission members are entitled to receive legislative per diem pursuant to the Maine Revised Statutes, Title 3, section 2; and be it further

Sec. 7. Report. Resolved: That the commission shall submit its report and recommendations for proposed changes to the rules to the Joint Standing Committee on Education no later than November 1, 1993.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve takes effect when approved.

## STATEMENT OF FACT

This resolve creates the Commission on Education Rules to 30 examine the Department of Education rules affecting school administrative units and to make recommendations for any 32 necessary changes to those rules.
