14	COMMITTEE AMENDMENT "A" to S.P. 305, L.D. 938, Bill, "An Act Regarding Visually Impaired Voters"
16	Amend the bill by inserting after the title and before the enacting clause the following:
18	
20	'Mandate preamble. This measure requires one or more local units of government to expand or modify activities so as to necessitate additional expenditures from local revenues but does
22	not provide funding for at least 90% of those expenditures. Pursuant to the Constitution of Maine, Article IX, Section 21,
24	two thirds of all of the members elected to each House have determined it necessary to enact this measure.'

28	Further amend the bill in section 1 in subsection 6 in the 3rd line (page 1, line 8 in L.D.) by inserting before the following: "enlarged" the following: 'enlarged specimen ballots
30	and'
32	Further amend the bill by striking out all of section 2 and inserting in its place the following:

36	'Sec. 2. 21-A MRSA §602, sub-§6-A is enacted to read:
30	6-A. Record. The clerk shall record and report to the

Further amend the bill in section 4 by striking out all of

subsection 3 and inserting in its place the following:

	'3. Assistance in reading the ballot. A voter who is
2	illiterate or visually impaired or has another disability that
4	makes it difficult to read a ballot may request that the ballot be read to that voter.
б	Further amend the bill by inserting at the end before the statement of fact the following:
8	statement of fact the following.
10	FISCAL NOTE
12	This bill requires local units of government to make additional expenditures for requiring municipal clerks to provide
14	a voting booth for the visually impaired at each voting place and to provide assistance to certain disabled voters by reading the ballot to them. Pursuant to the Mandate Preamble, the 2/3 vote
18	of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local
20	cost of these requirements.
22	The additional costs to collect reports regarding the number of enlarged specimen ballots and enlarged ballots made for visually impaired voters by municipal clerks can be absorbed by
24 26	the Department of the Secretary of State utilizing existing budgeted resources.'
28	STATEMENT OF FACT
30	The amendment allows clerks, with the permission of the Secretary of State, to make enlarged specimen ballots as well as
32	enlarged ballots. The Secretary of State will not have to provide the enlarged specimen ballots.
. 34	The amendment adds a reporting requirement. Clerks who make
36	enlarged specimen ballots and enlarged ballots must record and report the number of ballots made to the Secretary of State.
38	
40	The amendment strikes language allowing the reading of a ballot outside the hearing range of others to a voter needing assistance. This removes the opportunity for confusion that
42	might arise, since all voters must cast their ballots behind the guardrail at a polling place, pursuant to federal law.
44	The amendment also adds a fiscal note and a municipal
46	mandate.
