Amend the bill in section 1 by striking out all of section 1 and inserting in its place the following:

'Sec. 1. Authority established. There-shall-be-a The Town of Kittery Port Authority is established, consisting of and governed by a board of 7 members, 6 of whom shall-be are appointed by the selectmen town council of the Town of Kittery. At least 3 of said the appointive members shall must be permanent residents of the Town of Kittery, and shall the members serve for a term of 5 years, providing that of the first appointment hereunder, 2 shall be are appointed for a term of one year, one for a term of 2 years, one for a term of 3 years, one for a term of 4 years and one for a term of 5 years. Said The members shall serve until their successors are appointed and qualified. Any vacancy occurring in the membership of the appointive members shall-be is filled by the selectmen town council for the unexpired term. In addition to the 6 appointive members, the-chairman a member of the Town Planning Board by-wiftue-of-his-office designated by the chair of the Town Planning Board shall-be is a member of the port authority, if--such--a-board-exists--in--the--Town--of--Kittery. Otherwise --- the -7 th-- member - shall--be--appointed - by--the - board - of selectmen, - the -tenure - of - such - appointed - member - to - be - terminated upon-the-establishment-and-occupancy-of-the-office-of-chairman-of the-Town Planning-Beard serving for a term of 5 years or until membership on the planning board terminates, whichever occurs first. The board shall elect one of its members as a-chairman chair, one as a-vice-chairman vice-chair and one as secretary. The members of the board shall-receive -ne are not entitled to compensation for their services; but their reasonable expenses incurred in the performance of their duties shall must be paid by the Town of Kittery. The board shall-have has the right to adopt and alter a common seal and-to-alter--same, and to establish bylaws and regulations for the management of its affairs within the meaning of this authority, the laws of the State of Maine and the ordinances of the Town of Kittery.'
