'Mandate preamble. This measure requires one or more local 24 units of government to expand or modify activities so as to necessitate additional expenditures from local revenues but does 26 not provide funding for at least 90% of those expenditures. Pursuant to the Constitution of Maine, Article IX, Section 21, 28 two thirds of all of the members elected to each House have determined it necessary to enact this measure.

Emergency preamble. Whereas, Acts of the Legislature do not 32 become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, it is essential that this legislation take effect 36 before July 1, 1993 because Long Island will no longer be a part of the City of Portland after that date; and

Whereas, unless this legislation is enacted as an emergency 40 measure the composition of the Portland Harbor Commission will not comply with the laws of this State; and

Whereas, in the judgment of the Legislature, these facts 44 create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately 46 necessary for the preservation of the public peace, health and safety; now, therefore,' '

SENATE AMENDMENT " $\mathcal{D}$ " to COMMITTEE AMENDMENT "A" to S.P. 315, L.D. 948

Further amend the amendment in the first indented paragraph after the title in the first line (page 1, line 17 in amendment) by striking out the following: "Amend" and inserting in its place the following: 'Further amend'

Further amend the amendment by striking out the fiscal note and inserting in its place the following:

'Emergency clause. In view of the emergency cited in the preamble, this Act takes effect when approved.

## **FISCAL NOTE**

This bill requires local units of government to make additional expenditures for certain budgeting and rulemaking requirements. Pursuant to the Mandate Preamble, the two thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local cost of these requirements.'

## STATEMENT OF FACT

This amendment adds a mandate preamble and an emergency 26 preamble and clause to the bill.
