Be it enacted by the People of the State of Maine as follows:

Sec. 1. 7 MRSA §1808, first ¶, as amended by PL 1967, c. 204, is further amended to read: 4

6 Ne <u>A</u> biological product eentaining--living--erganisms--er wiruses capable of eliciting an immunological response offered 8 for use in the treatment or prevention of diseases of domestic animals shall may not be produced, sold, distributed, imported or used within the State, or imported into the State for sale, distribution or use unless approval and written permission has commissioner, 12 obtained from the first been or his the commissioner's agent in charge of livestock sanitary work, for 14 the distribution and use of such that product. The commissioner or his the counselor's agent has the right to refuse permission for such distribution, sale, importation or use of any such product within the State, and may require reporting of sale, distribution, importation or use of any such product within the 18 State, if permission is granted.

Sec. 2. 32 MRSA §13787, sub-§§1 and 3, as enacted by PL 1987, c. 710, §5, are amended to read:

24 1. Possession. A hypodermic apparatus may be possessed by a practitioner, <u>a</u> funeral director, <u>a</u> nurse, <u>a</u> manufacturer or 26 dealer in embalming supplies, а wholesale druggist, а manufacturing pharmacist, <u>a</u> pharmacist, <u>a</u> manufacturer of surgical instruments, <u>a farmer for use on that farmer's animals</u> 28 or poultry, an employee of an incorporated hospital acting under 30 official direction, <u>a</u> carrier or messenger engaged in the transportation of a hypodermic apparatus as an agent of any of 32 the persons named in this subsection, employees of scientific research laboratories, employees of educational institutions, 34 employees of an agency or organization duly authorized by the board or a person who has received a written prescription issued 36 under subsection 2.

38 3. Hypodermic apparatus. used in this section, As "hypodermic apparatus" has the meaning set forth in Title 17-A, 40 section 1101, subsection 2,-except-that--it-does--mot-include-a syringer-needle-or-instrument-for-use-on-farm-animals-and-poultry.

<u>§13787-A. Sale of hypodermic apparatus</u>

1. Definitions. As used in this section, unless the context otherwise indicates, the following terms have 48 the following meanings.

"Health care facility" means all facilities described in 2 Title 22, section 303 and any other facility designated by the commissioner as a health care facility for purposes of 4 this section. б' Β. "Health care practitioner" has the same meaning as "practitioner" in section 13702, subsection 23. 8 "Hypodermic apparatus" has the meaning set forth in С. Title 17-A, section 1101, subsection 2. 10 12 2. Sale authorized. Hypodermic apparatus may be sold by the following persons. 14 A. A health care facility or health care provider may sell 16 hypodermic apparatus to a patient of that facility or provider for use by that patient. 18 B. A licensed pharmacist may sell hypodermic apparatus to 20 any person authorized to possess that apparatus in section 13787. 22 C. A manufacturer, wholesaler or retailer licensed by the 24 board may sell to any person authorized to possess the apparatus in section 13787, provided the rules of the board authorize those sales. 26 28 3. License to sell hypodermic apparatus. The board shall establish by rule a process to license hypodermic apparatus 30 manufacturers, wholesalers and retail sales outlets other than pharmacies, health care facilities and health care practitioners. 32 <u>§13787-B. Disposal of hypodermic apparatus</u> 34 Hypodermic apparatus must be disposed of in accordance with rules adopted by the Department of Environmental Protection 36 pursuant to Title 38, section 1319-0. 38 40

STATEMENT OF FACT

Current law requires approval of the Commissioner of Agriculture, Food and Rural Resources for the sale of animal vaccines and other biological products that contain live organisms. This bill expands that regulation to biological products that contain dead organisms.

The bill also amends the law regulating hypodermic 50 apparatus, such as needles and syringes. The Maine Criminal Code

prohibits a person from possessing, selling or furnishing
hypodermic apparatus without specific statutory authorization.
The Maine Pharmacy Act permits certain persons to possess
hypodermic apparatus, but does not address the question of who may sell hypodermic apparatus. This bill clarifies that farmers
are permitted to possess hypodermic apparatus for use on their own farm animals and poultry. The bill also specifies who may
sell hypodermic apparatus, including pharmacies, health care facilities and practitioners, such as physicians and veterinarians, and manufacturers, wholesalers and retail outlets licensed by the Board of Commissioners of the Profession of
