An Act Authorizing the Commissioner of Inland Fisheries and Wildlife to Establish Open and Closed Seasons on the Hunting of Bear.

Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 12 MRSA §7451, sub-§1, ¶A, as amended by PL 1987, c. 4 171, is repealed and the following enacted in its place: A. #### (6)--The-bait-areas-will-be-cleaned-up-by-November-10, as-defined-by-the-state-litter-laws;-and

(7) The person hunting from any stand or blind of another person has permission of the owner of that stand or blind.

#### STATEMENT OF FACT

This bill allows the Commissioner of Inland Fisheries and Wildlife to establish open and closed seasons on the hunting of bear and to adopt other rules necessary for the protection of the bear resource. A general open season on bear hunting as well as an open season on bear hunting using dogs are currently established by law. This bill gives the commissioner the flexibility needed to establish bear hunting seasons that maximize the opportunity to hunt bear and at the same time ensure the welfare of the resource.
