This resolve establishes the Maine State 175th Anniversary Commemoration Commission and allows the Legislative Council to accept and administer outside sources of funding to conduct the study. If no outside funding is available, the commission may not incur expenditures. In particular, General Fund appropriations are prohibited.

10 The Office of the Secretary of State and the cultural bureaus can absorb the costs related to the membership of their employees on the commission within existing budgeted resources. The cultural bureaus can also absorb the costs related to providing staff assistance to the commission.'

The amendment includes a representative of the Maine Arts Commission as a member of the Maine State 175th Anniversary Commemoration Commission, requires that one person appointed to the commission be a member of one of Maine's native American tribes, specifies that an itemized account of revenues and expenditures must be provided in both the interim and final reports and also specifies that staff support to the commission will come from those cultural agencies represented on the commission. The amendment also adds the necessary fiscal note.
