SENATE AMENDMENT "A" to HOUSE AMENDMENT "A" to H.P. 883,
L.D. 1197, Bill, "An Act to Apportion the State's Senate, House
of Representatives and Congressional Districts"

Amend the amendment by striking out everything after the
title and inserting in its place the following:

'Amend the bill by striking out everything after the
enacting clause and before the statement of fact and inserting in
its place the following:

'Sec. 1. 21-A MRSA §1201, as amended by PL 1993, c. 7, §1, is
repealed.

Sec. 2. 21-A MRSA §§1202 to 1207 are enacted to read:

§1202. Definitions

As used in this chapter, unless the context otherwise
indicates, the following terms have the following meanings.

1. Block. "Block" means an area defined as a block in the
United States Census for 1990. A block is the smallest census
unit used in this chapter.

2. Block group. "Block group" means an area comprising all
of the blocks within a tract or BNA whose census data labels
begin with the same digit. There are one to 9 block groups in a
tract or BNA.

3. Block numbering area. "Block numbering area" or "BNA"
means that area composed of blocks or block groups that is
defined as a block numbering area in the United States Census for
1990.

2 4. Census unit. "Census unit" means a block, block group,
3 BNA or tract.

4 5. Commission. "Commission" means the Legislative
5 Apportionment Commission established every 10 years pursuant to
6 the Constitution of Maine, Article IV, Part Third, Section 1-A.

7 6. Tract. "Tract" means that area composed of blocks or
8 block groups that is defined as a tract in the United States
9 Census for 1990.

10 7. United States Census for 1990. "United States Census
11 for 1990" means the population counts published in both printed
12 and electronic media in March 1991 by the United States Census
13 Bureau as the data for the State of Maine collected pursuant to
14 Public Law 94-171.

15 §1203. General provisions

16 1. Implementation. The Secretary of State shall implement
17 the election districts adopted in this chapter pursuant to this
18 Title and the Constitution of Maine. The Secretary of State
19 shall inform the municipal clerks of the voting district or
20 districts in which each municipality lies and shall provide
21 copies of this chapter and district maps and narrative
22 geographic descriptions of relevant election districts to those
23 officials. The Secretary of State may resolve ambiguities
24 concerning the location of election district lines consistent
25 with subsection 2 and this chapter.

26 2. Interpretation. Where a road, street, waterway,
27 boundary of a tract, boundary of a block group or boundary of a
28 block is used as a boundary of an election district, the boundary
29 line lies at the center of the street or road, at the thread of
30 the waterway or at the boundary of the tract, block group or
31 block, unless otherwise noted. When a description refers to a
32 bridge or railroad line, the district boundary lies at the center
33 of the bridge or railroad tracks. When a description refers to a
34 railroad spur, it refers to the principal spur in the area. When
35 a description uses the word "ocean," the district boundary line
36 lies coincident with the legal boundary of the particular
37 community along or within the Atlantic Ocean. When an election
38 district includes a particular unorganized territory, it includes
39 that unorganized territory as described in the United States
40 Census for 1990, whether the territory is organized or
41 unorganized on the effective date of this chapter. Unless
42 otherwise noted, a district that names a municipality includes
43 all of the municipality.

§1204. Reapportionment

2 The state legislative districts established in this chapter
4 must be reapportioned pursuant to the Constitution of Maine,
6 Article IV, Part Third, Section 1-A, and congressional districts
 must be reapportioned as follows.

8 1. Procedure. In 1993 and every 10 years thereafter, when
 the Secretary of State has received notification of the number of
10 congressional seats to which the State is entitled and the
 Federal Decennial Census population count is final, the
12 commission shall review the existing congressional districts. If
 the districts do not conform to Supreme Judicial Court
14 guidelines, the commission shall reapportion the State into
 congressional districts.

16 In making such a reapportionment, the commission shall ensure
18 that each congressional district is formed of compact and
 contiguous territory and crosses political subdivisions the least
20 number of times necessary to establish districts as equally
 populated as possible. The commission shall submit its plan to
22 the Clerk of the House of Representatives no later than 120
 calendar days after the convening of the Legislature in which
24 apportionment is required. The Legislature shall enact the
 submitted plan of the commission or a plan of its own in regular
26 or special session by a vote of 2/3 of the members of each house
 within 30 calendar days after the plan is submitted to the Clerk
28 of the House of Representatives. This action is subject to the
 Governor's approval, as provided in the Constitution of Maine,
30 Article IV, Part Third, Section 2.

32 2. Court apportionment. In the event that the Legislature
 fails to make an apportionment within 150 calendar days of the
34 convening of the session in which apportionment is required, the
 Supreme Judicial Court shall make the apportionment within 60
36 days following the period in which the Legislature is required to
 act but fails to do so. In making the apportionment, the Supreme
38 Judicial Court shall take into consideration plans and briefs
 filed by the public with the court during the first 30 days of
40 the period in which the court is required to apportion.

42 3. Judicial review. The Supreme Judicial Court has
 original jurisdiction to hear any challenge to an apportionment
44 law enacted by the Legislature, as registered by any citizen or
 group of citizens. If a challenge is sustained, the Supreme
46 Judicial Court shall make the apportionment.

48 **Sec. 3. Legislative findings.** The Legislature finds that the



Force Base, which is scheduled to be closed before the
20 Legislature is next reapportioned. The closure will result in a
significant decrease in population, and the block is split in
22 order to spread the impact of that singular population variation
over the 2 legislative districts.' '

26 **STATEMENT OF FACT**

28 This amendment strikes the bill and replaces it with revised
districts that implement the recommendations of the minority
30 membership of the Legislative Apportionment Commission. The
revised districts for the Senate, House of Representatives and
32 congressional districts are based on population counts from the
1990 federal census.
