16 Amend the bill in section 1 in subsection 1 in paragraph A in the first line (page 1, line 8 in L.D.) by striking out the 18 following: "\$1 \$2" and inserting in its place the following: '\$1'

Further amend the bill in section 1 in subsection 1 in 22 paragraph B in the 2nd line (page 1, line 13 in L.D.) by striking out the following: "<u>\$1</u>" and inserting in its place the 24 following: '<u>50¢</u>'

Further amend the bill in section 1 in subsection 1 in paragraph C in subparagraph (1) in the 2nd line (page 1, line 22 in L.D.) by striking out the following: "<u>\$10</u>" and inserting in its place the following: '<u>\$7</u>' and by striking out the 30 following: "<u>\$4</u>" and inserting in its place the following: '<u>\$3</u>'

Further amend the bill in section 1 in subsection 1 in paragraph D in subparagraph (1) in the 2nd line (page 1, line 29 in L.D.) by striking out the following: "<u>\$10</u>" and inserting in its place the following: '<u>\$7</u>' and by striking out the following: "<u>\$4</u>" and inserting in its place the following: '<u>\$3</u>'

38 Further amend the bill in section 1 in subsection 3 in paragraph A in the first line (page 2, line 20 in L.D.) by 40 striking out the following: "<u>\$10</u>" and inserting in its place the following: '<u>\$7</u>' and in the last line (page 2, line 21 in L.D.) 42 by striking out the following: "<u>\$4</u>" and inserting in its place the following: '<u>\$3</u>'

Further amend the bill by inserting before the statement of fact the following:

'Sec. 2. Distribution of fees. Additional revenues collected by each municipal clerk as a result of this Act must accrue to the municipality.'

## STATEMENT OF FACT

This amendment deletes the increase in municipal clerk fees that are paid by municipalities and reduces the increases in fees for issuing a copy of a record of birth, marriage or death, a copy of an amended birth record and a certificate of birth, marriage or death. The amendment also requires that additional revenue collected as a result of this legislation accrue to the municipality.
