and each item vetoed must be voted on separately to override the veto. Except as provided in this section, the Governor may not disapprove, omit or modify any language allocated to the statutes or appearing in an unallocated section of law. This section does not apply to an enacted bill that includes appropriation or allocation sections but whose primary purpose is to enact, amend or repeal a section or sections of law.

STATEMENT OF FACT

This amendment incorporates the substance of House Amendment "A" to Committee Amendment "A" and, in addition, this amendment restricts use of the line-item veto to unified and supplemental budget bills and prohibits the Governor, when disapproving an item under the Constitution of Maine, Article IV, Part Third, Section 2-A, from proposing an increase in spending elsewhere in the bill.
