16 Amend the bill in section 3 in subsection 1 in the first paragraph in the 3rd line (page 1, line 29 in L.D.) by striking 18 out the following: "registered"

Further amend the bill in section 3 in subsection 1 in the 2nd paragraph in the first line (page 1, line 33 in L.D.) by striking out the following: "registered"

Further amend the bill in section 3 in subsection 1 in the 2nd paragraph by striking out all of the 3rd sentence (page 1, lines 37 to 39 in L.D.) and inserting in its place the following: 'Registration expires yearly on December--31st the anniversary date of the individual's initial registration or on such other date as the commissioner determines.'

Further amend the bill in section 7 in that part designated 32 "<u>\$14306-A.</u>" in subsection 1 in the first paragraph in the 3rd line (page 2, line 31 in L.D.) by striking out the following: 34 "certified"

36 Further amend the bill in section 7 in that part designated "<u>\$14306-A.</u>" in subsection 1 in the 2nd paragraph in the first 38 line (page 2, line 35 in L.D.) by striking out the following: "certified"

Further amend the bill in section 7 in that part designated 42 "**§14306-B.**" in subsection 1 in the next to the last line (page 3, line 12 in L.D.) by inserting before the following: "<u>American</u>" 44 the following: '<u>Commission on Massage Training</u> <u>Accreditation/Approval, or its successor organization. Further amend the bill in section 7 in that part designated "<u>§14306-B.</u>" in subsection 1 in the last line (page 3, line 13 in L.D.) by inserting after the following: "<u>Association</u>" the following: 'or graduates of schools approved by the American <u>Massage Therapy Association may be certified without proof of</u> <u>passing the National Certification Examination for Therapeutic</u> <u>Massage and Bodywork until January 1, 1995</u>' 7

10 Further amend the bill in section 8 in that part designated "§14308." in subsection 3 in the first paragraph in the 5th line 12 from the end (page 5, line 6 in L.D.) by striking out the following: "registered therapist <u>or certified practitioner</u>," and 14 inserting in its place the following: 'registered <u>practitioner</u> or certified therapist,'

Further amend the bill by inserting at the end before the statement of fact the following:

'FISCAL NOTE

22 Broadening the definition of massage therapist, certain changes in registration procedures and requirements and the 24 granting of reciprocity will result in insignificant increases of dedicated revenues to the Department of Professional and 26 Financial Regulation from registration fees.

28 The Department of Professional and Financial Regulation will incur some minor additional costs to adopt rules relating to 30 massage therapists. These costs can be absorbed within the department's existing budgeted resources.'

STATEMENT OF FACT

36 Current law requires that persons be registered with the State in order to call themselves massage therapists. Although 38 there is some confusion, the bill appears to require that persons must be registered in order to call themselves registered massage practitioners and must meet certain qualifications in order to 40 This amendment call themselves certified massage therapists. 42 requires that persons be registered in order to call themselves massage practitioners and meet certain qualifications in order to be certified and to call themselves massage therapists. 44

46 The bill requires that to be certified a person must pass an examination or have graduated from a school accredited by the 48 American Massage Therapy Association. This amendment requires that schools be accredited by the Commission on Massage Training 50 Accreditation/Approval, but until January 1, 1995 continues to

accept those schools accredited by the Massage Therapy Association and accepts membership in that association as a 3rd means, after the examination and schooling, of fulfilling the knowledge requirement for certification.
