COMMITTEE AMENDMENT "A" to H.P. 991, L.D. 1322, "Resolve, to Establish the Commission on the Status of Alleged Child Abusers"

Amend the resolve in section 2 in the first paragraph in the 2nd line (page 1, line 21 in L.D.) by striking out the following: "8" and inserting in its place the following: '6'

Further amend the resolve in section 2 in the first paragraph in the 6th line (page 1, line 25 in L.D.) by inserting after the following: "Representatives;" the following: 'and'

Further amend the resolve in section 2 in the first paragraph by striking out all of the last 4 lines (page 1, lines 27 to 30 in L.D.) and inserting in their place the following: 'Representatives; and be it further'

Further amend resolve in section 3 in the first paragraph by striking out all of the last sentence (page 1, lines 40 to 43 in L.D.) and inserting in its place the following: 'All members of the commission serve without compensation; and be it further'

Further amend the resolve in section 6 in the first paragraph in the last line (page 2, line 25 in L.D.) by striking out the following: "1993." and inserting in its place the following: '1993; and be it further'

Further amend the resolve by inserting after section 6 the following:

'Sec. 7. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.

24 \$500 in fiscal year 1993-94 for the Commission on the Status of

Legislature can absorb the costs related to staffing the  
commission if its meetings are held during the interim between  
sessions.'

30 **STATEMENT OF FACT**

32 This amendment reduces from 8 to 6 the number of members on  
34 the Commission on the Status of Alleged Child Abusers. The  
amendment provides that all commission members serve without  
36 compensation. The amendment also adds an appropriation section  
and a fiscal note.
