18	Amend the bill by striking out everything after the enacting clause and before the statement of fact and inserting in its place the following:
20	'Sec. 1. 22 MRSA §1628, sub-§2, as amended by PL 1989, c. 445,
22	§9, is repealed and the following enacted in its place:
24	2. Violation. It is unlawful for any person, firm or
26	corporation to knowingly distribute or sell cigarettes from a vending machine to a person under the age of 18 years or from any
40	vending machine except for a vending machine:

	A. From which only cigarettes are dispensed;

	B. On which is affixed to the front of the machine a
32	conspicuously displayed sign with letters at least 1/2 inch
34	in height stating: "WARNING: It is unlawful for a person

	This Committee of Conference Amendment replaces the bill.
6	This amendment makes the following changes from current law concerning the sale of cigarettes in vending machines.
8	
	1. The sale of cigarettes in vending machines is authorized
10	in those machines from which cigarettes only are dispensed.
12	2. A warning sign must be attached to cigarette vending
	machines stating that it is unlawful for minors to purchase
14	cigarettes.
16	This amendment also adds a fiscal note to the bill.
