**'FISCAL NOTE** 

22 This bill establishes a new Class E crime. Sentences imposed for Class E offenses must be served in a county jail.
24 The average cost per sentence for a Class E crime is \$4,188 based upon an average length of stay of 67 days. The additional costs
26 to the counties for the housing of each offender sentenced under this new crime will not require reimbursement by the State.

The additional workload and administrative costs associated with the minimal number of new cases filed in the court system related to this new Class E crime can be absorbed within the budgeted resources of the Judicial Department. The collection of additional fines may increase General Fund revenues by a minor amount.

This bill includes several new requirements that necessitate additional expenditures by local units of government. Pursuant to the mandate preamble, the 2/3 vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local cost of these requirements.'
