COMMITTEE AMENDMENT "A" to H.P. 1181, L.D. 1579, Bill, "An Act to Make Additional Allocations from the Public Utilities Commission Regulatory Fund for the Fiscal Year Ending June 30, 1994"

Amend the bill by striking out the title and substituting the following:

'An Act to Make Additional Allocations from the Public Utilities Commission Regulatory Fund for the Fiscal Years Ending June 30, 1994 and June 30, 1995'

Further amend the bill by striking out everything after the enacting clause and before the emergency clause and inserting in its place the following:

'Sec. 1. Allocation. The following funds are allocated from the Public Utilities Commission Regulatory Fund to carry out the purposes of this Act.

34 Under current law, the Maine Revised Statutes, Title 35-A, section 116, the Public Utilities Commission is authorized to request that the Legislature reallocate unexpended funds carried forward in the Public Utilities Commission Regulatory Fund. This bill provides allocations of unexpended funds totaling \$180,264 and \$200,000 in fiscal year 1993-94 and fiscal year 1994-95, respectively, to be used for consulting services, software installation and various computer replacements.

44 **STATEMENT OF FACT**

46 This amendment reallocates \$30,000 to fiscal year 1993-94 for the replacement of desktop computers and \$200,000 to fiscal year 1994-95 for the replacement of the Public Utilities Commission's central computer system.
