HOUSE AMENDMENT "D" to COMMITTEE AMENDMENT "A" to H.P. 16 1243, L.D. 1670, Bill, "An Act to Amend the Harness Racing Laws"

18 Amend the amendment by inserting after the title the following:

'Amend the bill by inserting after the title and before the 22 enacting clause the following:

24 'Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted
26 as emergencies; and

28 Whereas, this legislation affects off-track betting and simulcasting of horse races, which affect live harness racing in 30 the State; and

Whereas, the live harness racing season begins in Maine before the end of the 90-day period following adjournment; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,' '

Further amend the amendment in the first paragraph after the 42 title in the first line (page 1, line 22 in amendment) by striking out the following: "Amend" and inserting in its place 44 the following: 'Further amend'
