The Department of Agriculture, Food and Rural Resources will incur some minor additional costs to pay for the expenses of one additional member to the Pull Events Commission. These costs can be absorbed within the department's existing budgeted resources.'

STATEMENT OF FACT

This amendment increases the membership of the Pull Events Commission from 8 members to 9 members and permits the Pine Tree

Ox Association to appoint a member. The bill would have replaced the Maine Draft Horse and Ox Association appointee with a Pine

Tree Ox Association appointee. The amendment also adds a fiscal note and makes a necessary change to conform existing law to current drafting standards.
