Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, Resolve 1993, chapter 22 directs the Department of Human Services, Bureau of Health, Division of Maternal and Child Health to study available data to identify the extent of the problem of violence among children, teens and young adults in the State; and

Whereas, the Bureau of Health needs additional time to complete its study and the study deadline must be extended; and

Whereas, this extension must occur before the expiration of the 90-day period; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Sec. 1. Resolve 1993, c. 22, §1, amended. Resolved: That Resolve 1993, c. 22, §1 is amended to read:

Sec. 1. Study to identify extent of violence among children. **Resolved:** That the Department of Human Services, Bureau of Health, Division of Maternal and Child Health shall study available data to identify the extent of the problem of violence among children, teens and young adults in the State. The Division of Maternal and Child Health shall collaborate with the Department of Corrections, the Office of Substance Abuse and the Bureau of Children with Special Needs in conducting this study. In addition to identifying the problem, the study must assess the need for further steps, including any legislation necessary, and make recommendations that would reduce the incidence and impact 36 of violence among those at highest risk in a report to the Joint Standing Committee on Human Resources and the Executive Director 38 of the Legislative Council by Nevember-1,-1993 February 15, 1994.
