

**An Act to Amend the Classification of Part of the Presumpscot River and
One of Its Tributaries.**

Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26.

Be it enacted by the People of the State of Maine as follows:

Sec. 1. 38 MRSA §467, sub-§9, ¶A, as amended by PL 1989, c. 764, §9, is further amended to read:

- A. Presumpscot River, main stem.
 - (1) From the outlet of Sebago Lake to ~~its confluence with Dundee Pond~~ Little's Island - Class A.
 - (2) From ~~the outlet of Dundee Pond~~ Little's Island to Sacarappa Falls - Class B.
 - (3) From Sacarappa Falls to tidewater - Class C.

Sec. 2. 38 MRSA §467, sub-§9, ¶B, as amended by PL 1991, c. 499, §16, is further amended to read:

- B. Presumpscot River, tributaries - Class A unless otherwise specified.
 - (1) All tributaries entering below the outlet of Sebago Lake, unless otherwise listed - Class B.
 - (2) Crooked River and its tributaries, except as otherwise provided, excluding existing impoundments and excluding that area of the river previously impounded at Scribners Mill - Class AA.
 - (3) Stevens Brook (Bridgton) - Class B.
 - (4) Mile Brook (Casco) - Class B.
 - (5) Pleasant River and its tributaries (Windham and Gray) - Class A.

STATEMENT OF FACT

This bill changes the classification of the Presumpscot River Basin from Dundee Pond to Little's Island from Class B to Class A and upgrades the Pleasant River and its tributaries to Class A.

This document has not yet been reviewed to determine the need for cross-reference, stylistic and other technical amendments to conform existing law to current drafting standards.
