HOUSE AMENDMENT "H" to COMMITTEE AMENDMENT "A" to H.P. 1306, L.D. 1761, Bill, "An Act to Make Supplemental Appropriations and Allocations for the Expenditures of State Government and to Change Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1994 and June 30, 1995"

Amend the amendment by inserting at the end before the emergency clause the following:

PART DD

Sec. DD-1. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Part.


FISCAL NOTE

STATEMENT OF FACT

42 This amendment provides \$200,000 in funding for aid to
