## STATEMENT OF FACT

The amendment makes technical changes in the bill to accomplish the bill's purpose of establishing that filing fees of registers of deeds are the same for secured transactions as they are for other activities involving registers of deeds under the Maine Revised Statutes, Title 33, section 751.
