Resolved: That the Maine Technical College System is authorized and 2 directed to conduct a follow-up study to the 1991 report by the Commission to Review the Capacity of the Maine Technical College 4 The study must provide specific recommendations for System. legislation and changes in administrative policies and must 6 specifically review: 8 1. Deficiencies in the curriculum of the technical colleges; 10 Deficiencies in funding and equipment at the technical 2. 12 colleges generally and within specific courses and programs; Locations of technical colleges and the possible need 14 3. for new colleges; and 16 4. Other deficiencies and factors that result in long lists of students awaiting admission to the colleges; and be it further 18 Sec. 2. Study to be overseen by a committee. Resolved: 20 That the study required in section 1 of this resolve must be overseen by a 22 committee of 5 persons staffed by technical college personnel. The committee, known as the Technical College Study Committee, consists of the following: 24 26 1. One member appointed by the Governor; One member appointed by the President of the Senate; 28 2. One member appointed by the Speaker of the House of 30 з. Representatives; 32 One member appointed by the President of the Maine 4. Technical College System; and 34 36 5. One member who is chosen by the other 4 committee members and is the chair of the committee; and be it further 38 Sec. 3. Report completed. Resolved: That the Technical College Study Committee shall submit its report, including any necessary 40 legislation, to the First Regular Session of the 117th Legislature and the Governor no later than November 1, 1994. 42 44 STATEMENT OF FACT 46 This resolve creates the Technical College Study Committee to study the deficiencies in funding, equipment and curriculum 48 and problems with the campus locations of the Maine Technical College System as a follow-up to a 1991 report.
