I. At least one individual with experience in promoting the involvement of adults in national service and volunteerism.

The appointments may also include educators, including 12 representatives from institutions of higher education and local education agencies; experts in the delivery of human, 14 educational, environmental or public safety services to communities and persons; representatives of Indian Tribes; 16 out-of-school or at-risk youth; and representatives of programs that are administered or receive assistance under the federal Domestic Volunteer Service Act of 1973, 42 United States Code, 18 Section 4951 et seq. (1973). The commission must also seat a 20 liaison designated by the federal Corporation for National Service. The appointments must reflect some diversity with 22 respect to geography, race, ethnicity, age, gender, disability characteristics and political affiliation.

2. Terms of office. The appointed members serve 3-year
 terms, except, of the initial appointments, 5 terms expire June
 30, 1995; 5 terms expire June 30, 1996; and 5 terms expire June
 30, 1997. The Governor shall appoint members to vacancies on the commission as they occur or upon expiration of terms. Any
 vacancy must be filled for the unexpired portion of the term in which the vacancy occurs.
