The suspension of operations for a professional licensing board that has 25% or more of its positions as vacant for a certain length of time, would reduce revenues and expenditures for that board during the period of suspension. In addition, the operating expenditures and revenues of the Division of Licensing and Enforcement within the Department of Professional and Financial Regulation will be adversely affected by the suspension of operations of any of the boards for which it provides services.'

STATEMENT OF FACT

This amendment requires a board to suspend operations in the event that 25% of its positions are vacant for at least 8 months. Operations may not be resumed until the percentage of vacant board positions is less than 25% of the board's membership. The Legislative Council and the Governor must be notified in the event this provision is triggered.
