Amend the bill in section B-2 in subsection 2 in paragraph A in the 5th and 6th lines (page 4, lines 42 and 43 in L.D.) by striking out the following: "<u>nonprofit service organization</u>" and inserting in its place the following: '<u>insurer</u>'

Further amend the bill in section B-2 in subsection 2 in 30 paragraph A in the 8th and 9th lines (page 4, lines 45 and 46 in L.D.) by striking out the following: "<u>nonprofit service</u> 32 <u>organization</u>" and inserting in its place the following: '<u>insurer</u>'

Further amend the bill in section D-1 in subsection 1 in the 6th line from the end (page 6, line 18 in L.D.) by striking out the following: "an insured" and inserting in its place the following: 'to replace coverage under an uninsured' and in the next to last line (page 6, line 22 in L.D.) by inserting after the following: "policy" the following: 'or the uninsured employee benefit plan'

42 Further amend the bill in section D-2 in subsection 2 in paragraph A in the next to last line (page 6, line 50 in L.D.) by 44 inserting after the following: "policy" the following: 'or the uninsured employee benefit plan'

Further amend the bill in section D-3 in subsection 1 in the 6th line from the end (page 7, line 19 in L.D.) by inserting before the following: "<u>under</u>" the following: '<u>to replace</u> 50 <u>coverage</u>'

Further amend the bill by inserting at the end before the statement of fact the following:

'FISCAL NOTE

12 The Department of Human Services will experience an increase in undedicated General Fund revenue as a result of requiring 14 certain organizations to reimburse the Medicaid program for covered services the Medicaid program paid for according to the 16 coverage in the contract or certificate. The exact amount can not be determined at this time.'
