COMMITTEE AMENDMENT "A" to H.P. 1451, L.D. 1980, Bill, "An Act to Make Maine Law Consistent with the Federal Law Regarding the Omnibus Budget Reconciliation Act of 1993 and to Clarify Maine Laws Regarding Underwriting and Continuity"

Amend the bill in section B-2 in subsection 2 in paragraph A in the 5th and 6th lines (page 4, lines 42 and 43 in L.D.) by striking out the following: "nonprofit service organization" and inserting in its place the following: 'insurer'

Further amend the bill in section B-2 in subsection 2 in paragraph A in the 8th and 9th lines (page 4, lines 45 and 46 in L.D.) by striking out the following: "nonprofit service organization" and inserting in its place the following: 'insurer'

Further amend the bill in section D-1 in subsection 1 in the 6th line from the end (page 6, line 18 in L.D.) by striking out the following: "an insured" and inserting in its place the following: 'to replace coverage under an uninsured' and in the next to last line (page 6, line 22 in L.D.) by inserting after the following: "policy" the following: 'or the uninsured employee benefit plan'

Further amend the bill in section D-2 in subsection 2 in paragraph A in the next to last line (page 6, line 50 in L.D.) by inserting after the following: "policy" the following: 'or the uninsured employee benefit plan'

Further amend the bill in section D-3 in subsection 1 in the 6th line from the end (page 7, line 19 in L.D.) by inserting before the following: "under" the following: 'to replace coverage'

paragraph A in the next to last line (page 7, line 50 in L.D.) by
