SENATE AMENDMENT " $\mathcal{B}$ " to COMMITTEE AMENDMENT "A" to H.P. 1473, L.D. 2001, Bill, "An Act to Establish a Catastrophic Health Expense Program"

Amend the amendment by striking out everything after the title and before the statement of fact and inserting in its place the following:

'Amend the bill in section 2 in that part designated "<u>\$5219-J.</u>" in the first paragraph in the first line (page 1, line 10 in L.D.) by inserting after the following: "<u>trust</u>" the following: '<u>, except those subject to the alternative minimum</u> tax pursuant to section 5203-A,'

Further amend the bill in section 2 in that part designated "5219-J." in the first paragraph in the 2nd line (page 1, line 11 in L.D.) by striking out the following: "4.5%" and inserting in its place the following: '1.8%'

Further amend the bill by inserting after section 2 the following:

'Sec. 3. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

This bill repeals the nursing home care credit, establishes a catastrophic health expense credit, which will cost approximately \$2,000,000 in fiscal year 1994-95, and appropriates \$3,000,000 to General Purpose Aid for Local Schools in fiscal year 1994-95.

These changes will have no net impact on the General Fund in 30 fiscal year 1994-95.''

## STATEMENT OF FACT

This amendment incorporates all of Committee Amendment "A" and also changes the percentage of the credit allowed to an individual or trust from 4.5% to 1.8%. The additional funds available from the percentage change will be appropriated to General Purpose Aid for Local Schools.
