Sec. 1. 30 MRSA §6205, sub-§1,  $\P$ B, as amended by PL 1991, c. 720, §1 and affected by §2, is further amended to read:

B. The first 150,000 acres of land acquired by the secretary for the benefit of the Passamaquoddy Tribe from the following areas or lands to the extent that those lands are acquired by the secretary prior to January 31, 1991 2001, are not held in common with any other person or entity and are certified by the secretary by January 31, 1991 2001, as held for the benefit of the Passamaquoddy Tribe:

14 The lands of Great Northern Nekoosa Corporation located in T.1, R.8, W.B.K.P. (Lowelltown), T.6, R.1, N.B.K.P. (Holeb), T.2, R.10, W.E.L.S. and T.2, R.9, W.E.L.S.; the land of 16 Raymidga Company located in T.1, R.5, W.B.K.P. (Jim Pond), 18 T.4. R.5, B.K.P.W.K.R. (King and Bartlett), T.5, R.6. B.K.P.W.K.R. and T.3, R.5, B.K.P.W.K.R.; the land of the 20 heirs of David Pingree located in T.6, R.8, W.E.L.S.; any portion of Sugar Island in Moosehead Lake; the lands of Prentiss and Carlisle Company located in T.9, S.D.; any 22 portion of T.24, M.D.B.P.P.; the lands of Bertram C. Tackeff or Northeastern Blueberry Company, Inc. in T.19, M.D.B.P.P.; 24 any portion of T.2, R.8, N.W.P.; any portion of T.2, R.5, W.B.K.P. (Alder Stream); the lands of Dead River Company in 26 T.3, R.9, N.W.P., T.2, R.9, N.W.P., T.5, R.1, N.B.P.P. and T.5, N.D.B.P.P.; any portion of T.3, R.1, N.B.P.P.; any 28 portion of T.3, N.D.; any portion of T.4, N.D.; any portion 3Ò of T.39, M.D.; any portion of T.40, M.D.; any portion of T.41, M.D.; any portion of T.42, M.D.B.P.P.; the lands of 32 Diamond International Corporation, International Paper Company and Lincoln Pulp and Paper Company located in 34 Argyle; and the lands of the Dyer Interests in T.A.R.7 W.E.L.S., T.3 R.9 N.W.P., T.3 R.3. N.B.K.P. (Alder Brook 36 Township), T.3 R.4 N.B.K.P. (Hammond Township), T.2 R.4 N.B.K.P. Academy т.2 R.3 (Pittston Grant), N.B.K.P. 38 (Soldiertown Township), and T.4 R.4 N.B.K.P. (Prentiss Township), and any lands in Albany Township acquired by the Passamaquoddy Tribe before January 1, 1991; and, if a 40 tribal-state compact under the federal Indian Gaming 42 Regulatory Act is agreed to by the State and the Passamaquoddy Tribe or the State is ordered by a court to 44 negotiate such a compact, any lands not exceeding 100 acres in the City of Calais approved by the legislative body of that city for acquisition by the tribe. 46

Sec. 2. Tribal ratification. This Act is not effective unless within 60 days of the adjournment of the Legislature, the

Secretary of State receives written notification by the Joint Tribal Council of the Passamaquoddy Tribe that the tribe has agreed to the provisions of this Act pursuant to the United States Code, Title 25, Section 1725(e)(1), copies of which must be submitted by the Secretary of State to the Secretary of the Senate, the Clerk of the House of Representatives and the Office of the Revisor of Statutes.

### STATEMENT OF FACT

This bill permits the Passamaquoddy Tribe to acquire and have taken into trust 100 acres of land in the City of Calais if the tribe and the State agree to a compact under the federal Indian Gaming Regulatory Act or if the State is ordered by a court to negotiate such a compact. The acquisition must be approved by the legislative body of that municipality.
