HOUSE AMENDMENT "A" to H.P. 1485, L.D. 2011, Bill, "An Act Regarding State Government Evaluation and Justification"

Amend the bill by inserting after section 1 the following:

'Sec. 2. 3 MRSA §923, sub-§3, as enacted by PL 1989, c. 483, Pt. A, §4, is amended to read:

3. Independent agency. "Independent agency" means a governmental entity subject to review pursuant to this chapter and to automatic termination unless continued by Act of the Legislature pursuant to this chapter.'

Further amend the bill in section 4 in that part designated "§925-A." in subsection 1 in the 10th line (page 1, line 50 in L.D.) by striking out the following: "may" and inserting in its place the following: 'shall'

Further amend the bill in section 10 in that part designated "§930." in the 2nd line (page 3, line 34 in L.D.) by striking out the following: "shall may" and inserting in its place the following: 'shall'

Further amend the bill by renumbering the sections to read consecutively.
