36	Resolved: That the Department of Mental Health and Mental Retardation, Division of Mental Health is directed to undertake
38	an expedited process to determine the need for community-based mental health resources to serve senior citizens in eastern and
40	northern Maine and to develop those resources in a timely manner with the funds appropriated in this resolve.
42	1. Determination of need and resource availability. The
44	Department of Mental Health and Mental Retardation shall conduct a study, which must include a survey and assessment of consumer
46	needs, to determine the need for and availability of community-based mental health resources to serve senior citizens
48	in eastern and northern Maine. For the purpose of the study, the
50	department shall convene a study group of mental health consumers and their families, mental health providers, advocates for consumers of mental health corviges and representatives of the

Community-based 8 mental health resources must be developed to meet the needs identified in each region and must serve at least 33 persons. 10 Resources for at least 16 persons must be available no later than June 30, 1996 and resources for at least 17 additional persons 12 must be available no later than December 30, 1996; and be it further

20	eastern Maine. Beginning in fiscal year 1997-98, the annual General Fund cost of these beds is estimated to be \$1,100,000.'

24	STATEMENT OF FACT
26	This amendment replaces the resolve. It deletes the emergency provisions. It removes the provisions to develop
28	resources at Bangor Mental Health Institute. It requires the Department of Mental Health and Mental Retardation to determine
30	the needs for community-based mental health resources to serve senior citizens and to develop those resources in the eastern and
32	northern Maine regions. It involves consumers and their families, advocates for consumers, providers of mental health
34	services and the department in the process. It requires the department to develop the needed resources within the limitations
36	of the funds appropriated. It adds a fiscal note to the resolve.
